Super Gateway



What is it?

SMSF's have many moving parts. You will have at the very least a Bank Account, Online Broking Account, Term Deposit Platform and also your Online Portfolio. You may also choose to add a managed share account, share research tool and other add-on's from preferred suppliers. The aim of Super Gateway is to provide you with links to these providers and your portfolio in one place. We do this by providing Icons that correspond with various actions that you want to undertake. For example, we have an icon called "My Portfolio", when selected will display all the SMSF accounting and financial information of your SMSF in the one screen.

How to gain Access to Super Gateway?

Super Gateway does not require passwords to enter. You can enter Super Gateway by clicking on the "Super Gateway" link on the Supervision website www.supervision.com.au.



What should I see there?

Once you have clicked on the Super Gateway link, you will land on a page that has a number of articles and a series of icons on the top row.



"My Portfolio"

When you click on this link you will be taken to your online portfolio. This is your view of your SMSF records. All of your banking transactions, investments, contributions, pensions and performance is in this place. To gain access, please call us now and we can establish this together in 5 minutes. All you need is your computer and your email. You can maintain your password for "My Portfolio" at any time and request a password refresh if you forget it.

"My Portfolio" has a large array of information about your SMSF or Non SMSF assets at your disposal, too much to explain in this document. You may notice layout changes and new data features added all the time. Our experience tells us that most clients view a particular area and don't venture too far off the beaten track. That is OK, just remember that exploration is free and you will never know what is available unless you apply a curious mind.

Here are some of the "Most Loved" Features

Bank Accounts

You can view all of your banking transactions line by line just like you can on your bank statement. It also shows you how that transaction has been coded by our team of professionals. If you have multiple bank accounts you can view them all in this section.

Contribution Caps

To avoid going over the contribution caps or just checking that your contributions are reaching your bank account, this section has all the information you could dream of. It breaks down contributions by members and creates a living cap calculator which tells you how much you can contribute. This is extremely important when you want to plan salary sacrifice or personal concessional contributions.

Pensions

If your SMSF is providing you with a pension, you need to make sure you take out enough to meet your minimum requirements. "My Portfolio" makes that simple by calculating pensions taken for each member and telling you how much is left to draw.

Investment Valuation

In order to make sure that your SMSF is headed in the right direction, this section provides all the information you need to track your SMSF investments. The advantage of this system is that all holdings are available so that you have a total view of your SMSF valuation- not just a snapshot of a particular investment class that is held on one platform. With updated prices for listed investments, you are always in control of your total market value. Includes cash, Managed investments, listed shares, Property, everything in your SMSF.

Unrealised Capital Gains

Our report breaks down every share into their purchase parcels and gives you an up to date capital gain or loss position. This is extremely handy when you are looking to rebalance your portfolio. You know exactly how much profit or loss each parcel has before taking action.

Performance Report

The performance report outlines total return values & total return as a percentage for every holding in your portfolio. In addition there is a time weighted average comparison to major indices to see how your SMSF compares.

Fund Reports

All of your historical accounting information is stored in this section. Download your P & L, Balance Sheet, Members Statements from any period and receive the reports instantly when you want them.



"Invest & Transact"

This icon is where you will find all of the links to your transactional accounts. These are the working parts of your SMSF. Entering Invest & Transact you will give you access to links such as "Banking", "Listed Securities", "Term Deposits", "Property", "Managed Portfolio's", "Insurance", "Finance Broking", "Share Market Research", "Bonds" and many more. This is where the rubber hits the road and you can buy and sell shares, get a term deposit, purchase insurance and view the next property for your portfolio.
